EUCROF is very pleased that POLCRO has decided to become a member and looks forward to working with its Executive Board and CRO members over the coming years.

EUCROF is a legal non-profit entity founded in 2005 and representing the interests of CROs in Europe towards Regulatory bodies, Pharmaceutical, biotech, medical device industry, Healthcare related industry within the field of clinical research and Patient associations. EUCROF's goal is to promote Clinical Research by improving the knowledge, competence and skills of CROs.

With the welcome addition of POLCRO, EUCROF's membership consists of 15 national associations of CROs within Europe, plus Associate Members from 10 further countries where no national associations currently exist plus 7 partner members from countries outside of Europe including the USA, North Africa, Middle East, and Australia. In total EUCROF's global reach continues to expand and covers 31 countries with over 450 CROs.



EUCROF's Executive Board consists of five members.



EUCROF has become an active Stakeholder of the EMA, contributing positively in many initiatives including the EU Clinical Trial Information System (CTIS), the EU Decentralised Clinical Trials project,

and European Network of Paediatric Research (Enpr-EMA), they are a member of Industry Stakeholders quarterly meeting as well as a member of ACT EU Multi-Stakeholder Platform. In addition to the EMA, EUCROF has established collaborations with many international stakeholders.

EUCROF is in the final stages of establishing a **GDPR Code of Conduct for CROs**, which will be the first international code of its type for clinical research and is expected to be approved by the European Data Protection Board and thereafter implemented in 2024.

EUCROF encourages the initiatives of its Members to form **Working Groups (WGs)**, which represent an

open area of discussion on specific areas of interest for Members. The Events and Training Working Group holds multiple webinars throughout the year covering key topics in Clinical Research.

Representatives of EUCROF attend on average over 20 internal events each year involving many of its Subject Matter Experts within its membership.

Every two years EUCROF holds a European Conference on Clinical Research. The next conference will be held be held in Prague on 19 & 29 February 2024 and has an extensive programme with excellent speakers covering key topics in our sector.
